TEF Gold Outstanding Alumni Scholarship: Terms and Conditions 2018

- 1. International scholarships and discounts including this Scholarship are only available to students who are assessed by De Montfort University (DMU) as having overseas international student status, and who pay overseas international rate tuition fees.
- 2. The Scholarship is open to alumni, which means students who have studied and successfully completed a degree at DMU Leicester campus (referred to in these terms as Alumni').
- 3. The £3,000.00 Scholarship is available to all Alumni and the £5,000.00 Scholarship is available to graduates achieving an upper second or a first class degree in all cases subject to the criteria set out in and these terms and conditions.
- 4. To be eligible for the Scholarship, international students must have successfully completed their degree in 2018 or have successfully completed their degree within the last two years (2017 or 2016)
- 5. Only students who will be studying on site at the DMU Leicester campus on full-time courses are eligible to apply for scholarships and discounts.
- 6. Students studying on part-time and distance learning courses or courses with fees lower than the lowest standard international fee, currently £12,250 are not eligible for the scholarship. Please check the course pages of the DMU website to view international fees and ensure your chosen course is eligible.
- 7. International Year Zero, International First Year and International Incorporated Master's applicants are not eligible for De Montfort University discounts or scholarships, but can apply for merit-based scholarships and Leicester International Pathway College awards. See the website for more details.
- 8. Scholarships and discounts will be applied to tuition fees at the point of registration unless otherwise stated on the relevant pages of the DMU website. Scholarship recipients will be notified by email within three weeks of the Registration closing date unless otherwise stated.
- 9. This Scholarship is only available to Alumni joining the university in September 2018 January 2019. It is not possible to defer the award until a subsequent entry point.
- 10. Students receiving a scholarship or discount will not be eligible for any additional award unless stated otherwise on the September 2018 scholarships and discounts webpages. If a student is eligible for more than one scholarship or discount, he or she will receive the higher value award only.
- 11. The value of the scholarship will be deducted from tuition fees for the first year of study only. The award will not be applied in subsequent years of study including repeated first year.
- 12. Unless otherwise stated, no cash alternatives will be offered. Awards cannot be transferred to another recipient.

- 13. Only self-funded students are eligible for scholarships. Students in receipt of any type of sponsorship will not be eligible.
- 14. DMU reserves the right to cancel any award, which has been claimed fraudulently, including on the basis of, deliberate provision of false information to claim the award, and to apply the full tuition fee. If a cash award is found to have been claimed fraudulently, the award amount will be added to the student's university account and must be paid in full before the end of the student's course.
- 15. Where a student terminates or interrupts their studies prior to the completion of their course, both the tuition fees and award will be pro-rated, based on the student's last date of attendance.
- 16. Recipients of a scholarship or discount must have no outstanding debt to the university.
